Order : This petition coming on for orders upon perusing the petition and the affidavit filed in support thereof and upon hearing the arguments of M/S.P.R.THIRUNEELAKANDAN, Advocate for the petitioner and of MR.JOHN ZACHARIAH FOR M/S. FOX MENDEL AND ASSO., on behalf of the 1st Respondents the court made the following order:-

The respondents are hereby directed to comply with the provisions of Section 17-B of the Industrial Dispute Act by paying the last drawn wages with effect from the date of filing of the writ petition to the writ petitioner. The arrears of wages are directed to be paid within a period of six weeks from the date of receipt of a copy of this order and thereafter monthly payment shall be paid on or before 7th of every month, till the disposal of the writ petition.

2. Accordingly, the writ miscellaneous petition is disposed of.
