(W.P.No.7323 of 2012 : Writ Petition is filed under article 226 of the constitution of India to issue a Writ of Certiorarified Mandamus calling for the records comprised in the proceedings of the Respondents herein with respect to collection of current and arrear demand of property tax sent by e-post to the petitioner dated 07.03.2012 with respect to the property situate at door No. 38 General Patters Road, Chennai 600 002, and quash the same as illegal and consequently issue a mandamus directing the respondents herein not to levy, impose, demand, assess and collection of property tax including not to bring the property situate at Door No.38, General Patters Road, Chennai - 600 002 for distraint sale pursuant to the demand made to e- post dated 7.3.2012 other than in accordance the provisions contained in Chennai Municipal Corporation Act, 1919.

W.P.No.7323 of 2012 : Writ Petition is filed under article 226 of the constitution of India to issue a Writ of Certiorarified Mandamus or any other appropriate Writ, order or direction in the nature of a Writ of Certiorarified Mandamus, by Calling for the records comprised in the proceedings of the respondents herein with respect to collection of current and arrear demand of Property Tax sent by E-Post to the petitioner dated 5.3.2012 with respect to the property situate at Door No.37 present bearing No.37/1C, 37/1D, 37/5 and 37/6 and quash the same as illegal and consequently issue a Mandamus directing the respondents herein not to levy, impose, demand, assess and collection of property tax including not to bring the property situate at Door No.37 presently Door Nos.37/1C, 37/1D, 37/5 and 37/6 General Patters Road, Chennai-600 002 for distraint sale pursuant to the demand made to E-Post dated 5.3.2012)

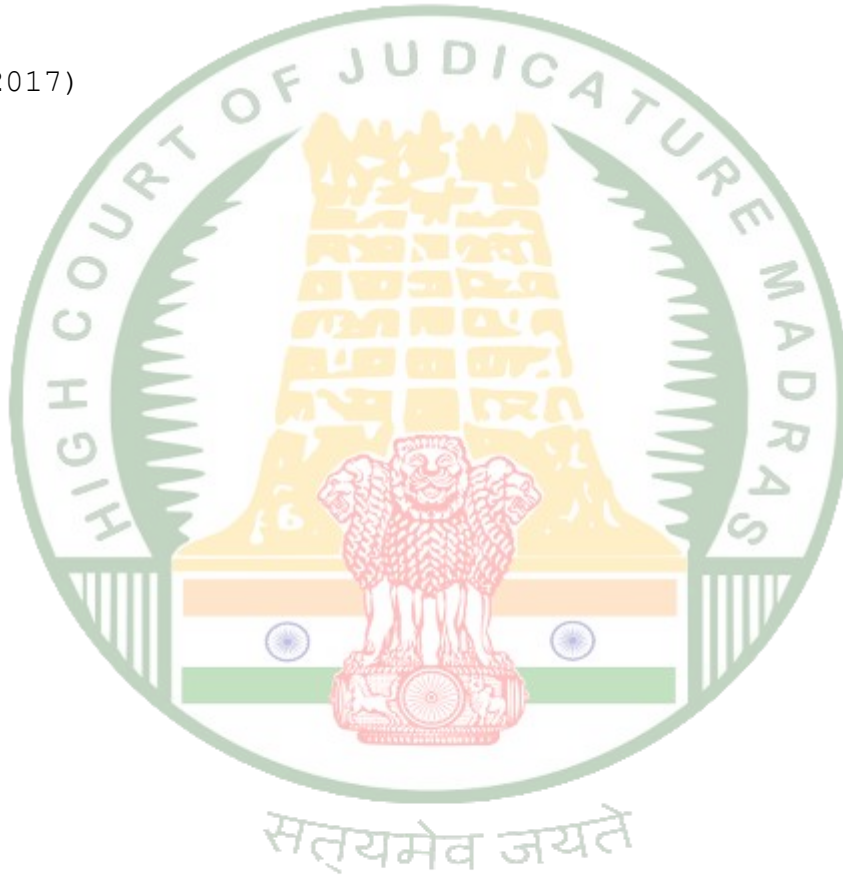
