Prayer:- Writ Petition filed under Article 226 of the Constitution of India praying for issuance of a Writ of certiorarified mandamus calling for the records on the file of the 2nd respondent in Memo No.025/6089/E1/TNSTC [VPM]/2007 dated 16.04.2007 in respect of fixation of Seniority of the respondents 3 to 16 for the post of Assistant Manager and the consequential order of the 2nd respondent in Lr.No.342/24608/E1/TNSTC[V]2014 dated 21.04.2014 and the Proce.No.351/26607/E1/TNSTC [VPM] 2014-2 dated 12.01.2015 of the 2nd respondent, quash the same and direct the 1st and 2nd respondents to refix the seniority of the petitioner above the
