2. It is submitted by the learned counsel for the petitioner that due to the petitioner's age related ailments and also heart problem, he is not in a position to sign every month.

3. Learned Special Public Prosecutor appearing for the respondent submits that the petitioner has been complying with the conditions imposed by this court without any default.

4. In the circumstances, this court is inclined to modify the order dated 12.05.2016 passed in M.P.No.5607 of 2016 in Crl.A.No.370

of 2016. Accordingly, the petitioner shall appear before the learned Special Judge / Chief Judicial Magistrate, Erode at 10.30 a.m., on the first working day, once in three months, pending appeal.
