4. Considering the fact that Circular No.67 itself has already been withdrawn on 20.10.2017, the relief sought in the petition has become infructuous and therefore, the present writ petition deserves to be dismissed.

5. In fine, the writ petition stands dismissed as infructuous without costs. Consequently, connected miscellaneous petition is closed.
