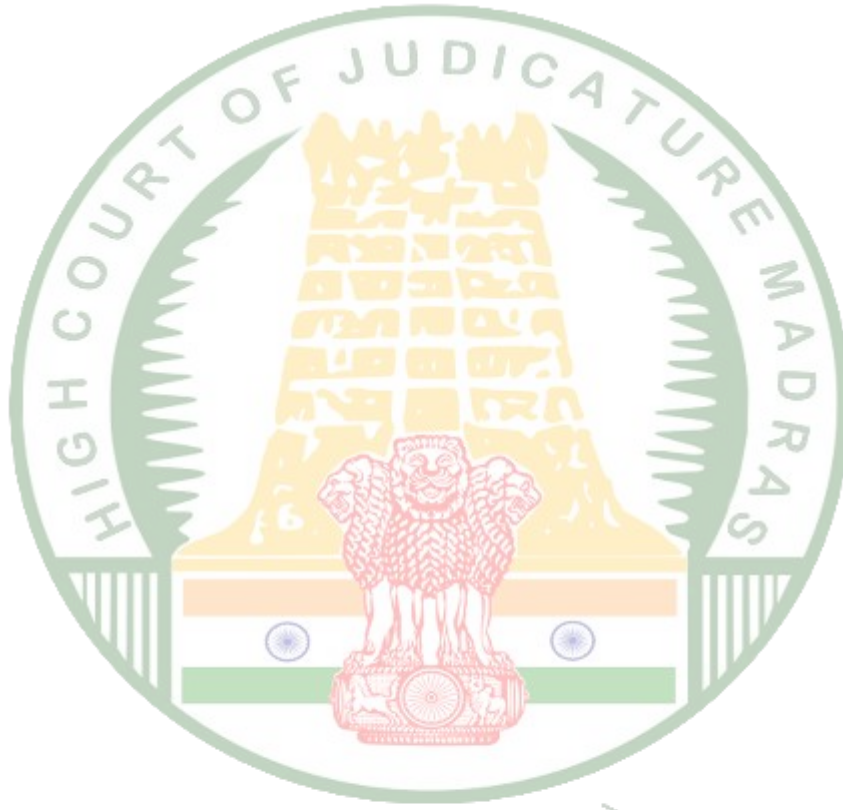

But till date, the third respondent has not officially announced the selection list. While so, it is not known how the petitioner has come to this Court on the premise that another candidate recommended by the local MLA is going to be shortlisted. Such a premise and presumption cannot be the ground to come to this Court seeking a writ of mandamus to consider her candidature. Therefore, the writ petition being premature is dismissed. No costs.
