2.The learned Special Government Pleader appearing for the respondents 1 and 2, on instructions, would submit that as per the proceedings of the 1st respondent dated 06.06.2016, a sum of Rs.33,08,757/- by way of gratuity amount has been paid to the petitioners in compliance with the order of the Labour Court, Salem and action is being taken to recover the interest amount.

3.Taking into consideration the finality of the proceedings dated 01.06.2016, the respondents 1 and 2 are hereby directed to see to it that the interest components payable to the petitioners are paid to the petitioners within a period of eight weeks from the date of receipt of a copy of this order.

4.With the above direction, the writ petition is disposed of.
