These petitions are filed seeking to relax the condition imposed on the petitioners/appellants.

2. It is stated in the affidavits filed in support of the petitions that the petitioners have been appearing regularly before the Principal Sessions Judge, Special Court for Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989, Dharmapuri, on the first working day of every month and complied with the conditions regularly.

3. Heard Mr.K.Srinivasan, learned Special Public Prosecutor, appearing for the respondent-State on the above submissions.

4. Considering the reasons stated in the petitions, these petitions are allowed and the conditions imposed in Crl.M.P.Nos.2 of 2012, 2 of 2014 and 3 of 2012 in Crl.A.No.671 of 2011 is modified to the effect that the petitioners shall appear before the said court on the first working day once in three months at 10.30 a.m, until further orders.

5. Petitions are ordered accordingly.
