ORDER

The relief sought for in this writ petition is for a direction, directing the 3rd respondent to consider the representation of the petitioner dated 07.10.2013 and pass orders in respect of the arrears of salary.

2. The learned counsel appearing for the writ petitioner contended that the writ petitioner was initially appointed as 'Night Watchman' in the regular vacancy on Time Scale of Pay through the order of the 2nd respondent dated 27.12.2000.

3. However, the learned counsel appearing for the petitioner further contended that the claim relating to the salary for the interregnum period has not been considered by the 3rd respondent, more specifically with effect from 01.01.2011 to 01.06.2013 and in this regard, the writ petitioner submitted a representation to the 3rd respondent dated 07.10.2013 and the same is yet to be considered.

4. Thus, this Court without going into merits and demerits of the case, directs the 3rd respondent to consider the representation submitted by the writ petitioner on 07.10.2013 and pass final order on merits and in accordance with law within a period of twelve weeks from the date of receipt of copy of this order.

5. With these direction, the writ petition stands disposed of. No cost. Consequently, connected miscellaneous petition is also closed.
