Now, the petitioner has come up with the present petition to relax the said condition.

3. Heard Mr.K.Srinivasan, learned Special Public Prosecutor, appearing for the respondent-State on the above submissions.

Considering the reasons stated in the petition, this petition is allowed and the conditions imposed in Crl.M.P.No.8009 of 2016 in Crl.A.No.330 of 2016 is modified to the effect that the petitioner shall appear before the said court on the first working day, once in six months at 10.30 a.m, until further orders.
