Prayer in W.P.No.26994 of 2017: Petition has been filed under Article 226 of the Constitution of India, to direct the second respondent herein not to grant any transfer of pattas in respect of i.e, the Plot No.SP/1 and SP/2 in S.Nos. 67/2 and 68 measuring about 14,400 sq.ft., of Mogappair Village, the then Saidapet Taluk now Ambattur Taluk, the then Chengalpet District now Thiruvallur District situated in Sathya Nagar, which is meant for exclusively for public purpose more fully described in the schedule to the accompanying petition by way

of issuance of a Writ of Mandamus or by any other writ, order or direction in the nature of a writ.

Prayer in W.P.No.26995 of 2017: Petition has been filed under Article 226 of the Constitution of India, to direct the first respondent herein to annul the so far registered documents fraudulently and unlawfully created encumbering properties situate in Plot No.SP/1 and SP/2 in S.Nos. 67/2 and 68 measuring about 14,400 sq.ft., which is exclusively meant for public purpose, more fully described in the schedule to the accompanying petition by way of issuance of a Writ of Mandamus or by any other writ, order or direction in the nature of a writ.

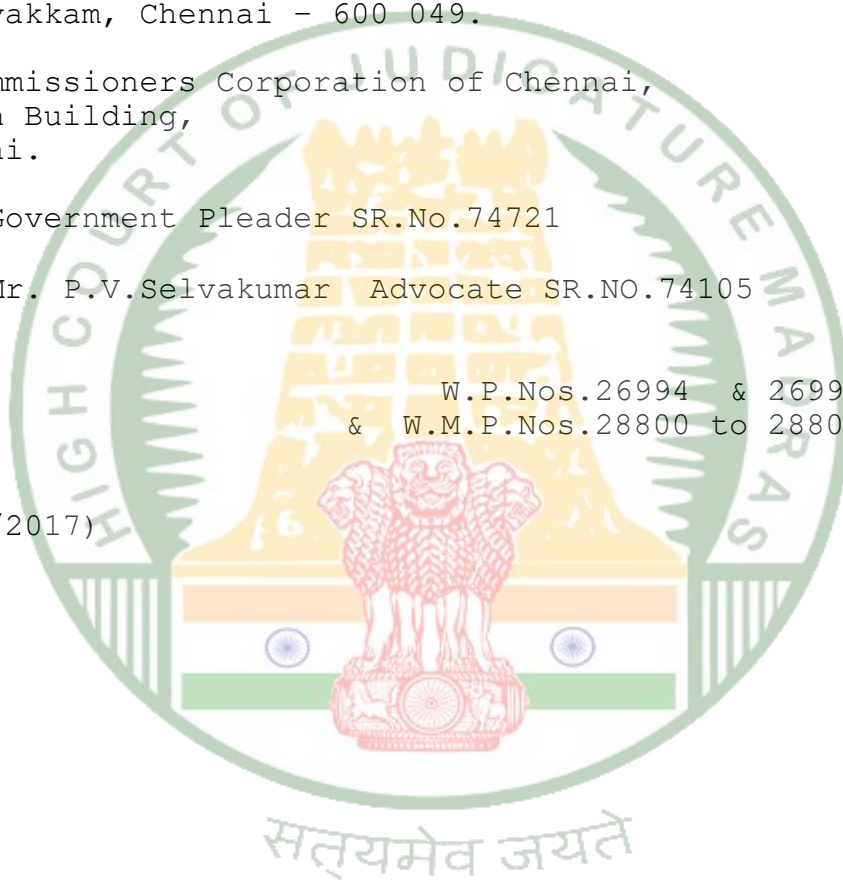
