ORDER

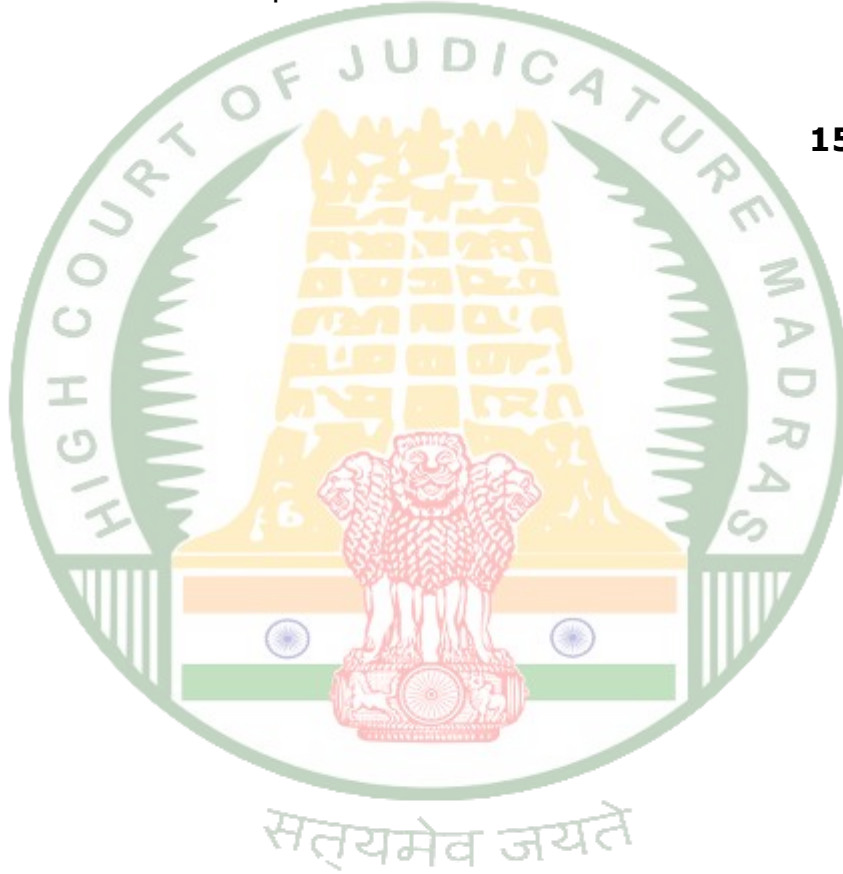
The learned counsel for the petitioner seeks permission of this Court to withdraw the above Civil Revision Petition and he has also made an endorsement to the effect that:

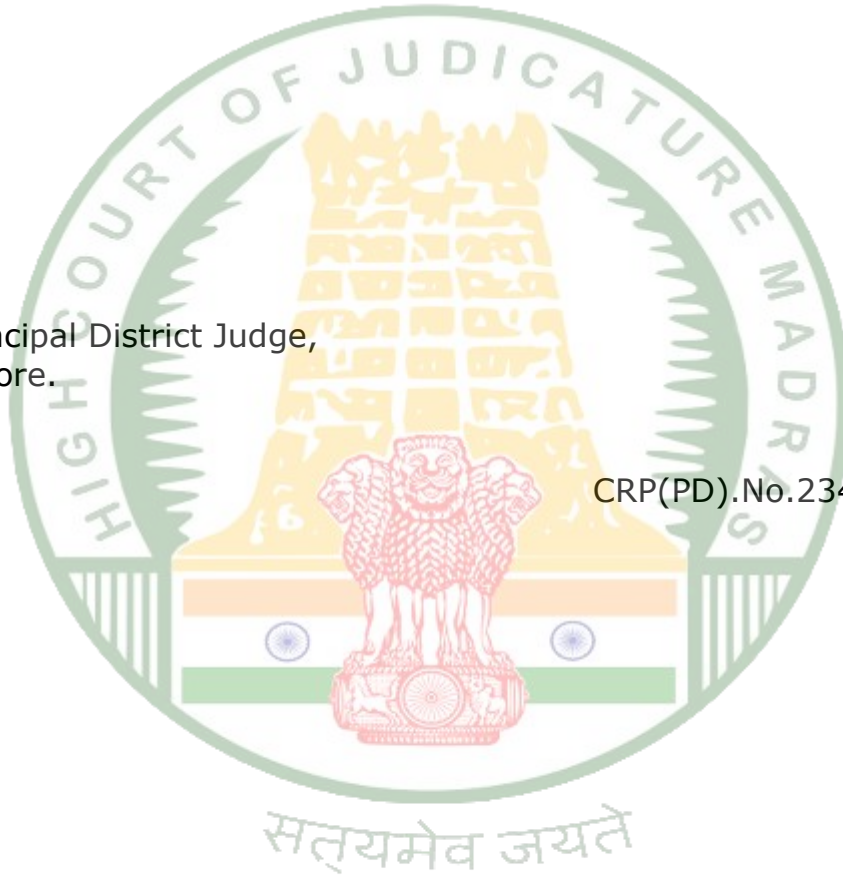
