Now, the petitioners have come up with the present petitions to relax the said condition.

3. Heard Mr.E.Raja, learned Additional Public Prosecutor, appearing for the respondent-State on the above submissions.

Considering the reasons stated in the petitions, these petitions are allowed and the conditions imposed in Crl.M.P.Nos.5141 & 5142 of 2016 in Crl.A.No.338 of 2016 is modified to the effect that the petitioners shall appear before the said court on the first working day once in three months at 10.30 a.m, until further orders.
