COMMON ORDER

The petitioner has filed the writ petition in W.P.No.8345 of 2004 challenging the impugned auction notice and also filed W.P.No.8346 of 2004 seeking direction to the second respondent to give the figures for one time settlement and reasonable time for payment of 20% amount. While entertaining the writ petitions, this Court passed interim order on condition to deposit 50% of the auction amount and the petitioner also complied with the order. The learned counsel for the petitioner further submitted that subsequently, the petitioner paid the entire amount and auction was also cancelled. Hence, nothing survives in these writ petitions for adjudication and the same is accordingly, closed. No costs. Consequently, the connected miscellaneous petition is also closed.
