3. I Heard the submissions of Mr.P.Ganesan, learned counsel appearing for the petitioner and Mr.A.Rajaperumal, learned Additional Government Pleader for the respondents.

Without going into the merits of the case, this Court directs the second respondent to consider the petitioner's representation dated 31.07.2012 by giving personal opportunity to the petitioner and to pass orders, on merits and in accordance with law, within a period of eight weeks from the date of receipt of a copy of this order.

5. This Writ Petition is disposed of accordingly. No costs.
