The learned counsel appearing for the petitioner seeks the permission of this Court to withdraw this writ petition and has also made an endorsement to that effect in the petition.

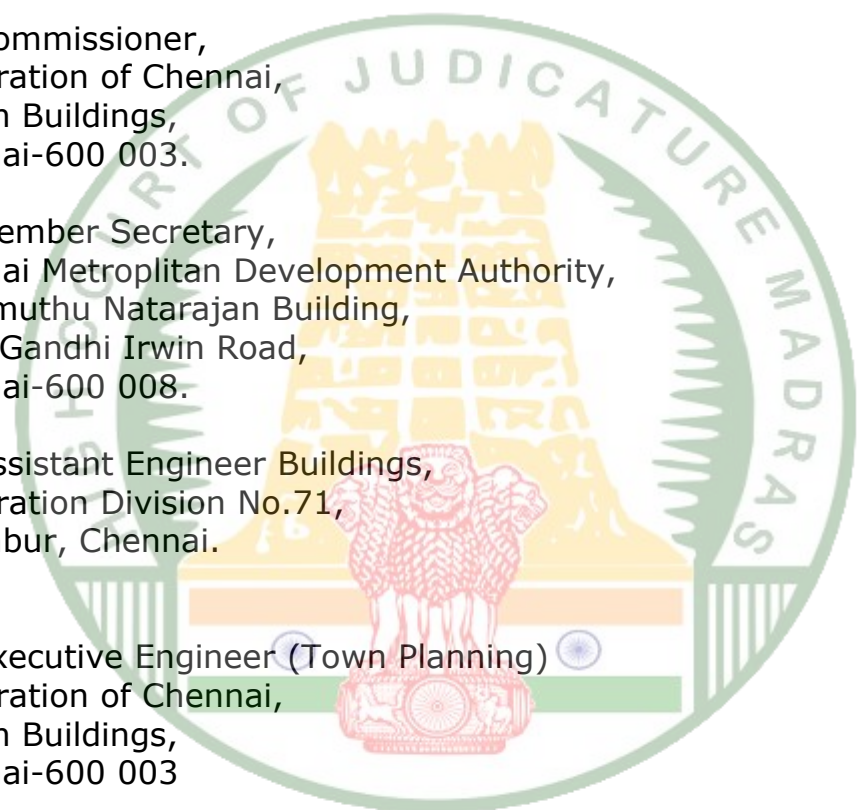
2.Recording the endorsement made by the learned counsel appearing for the petitioner, this writ petition is dismissed as withdrawn. No costs.

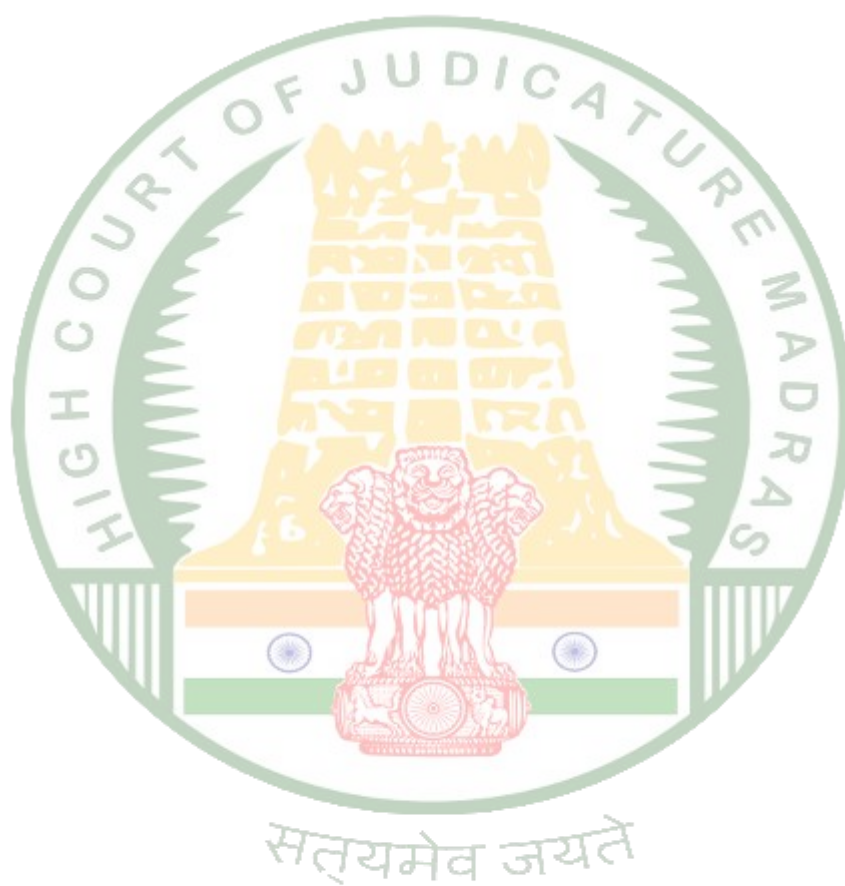

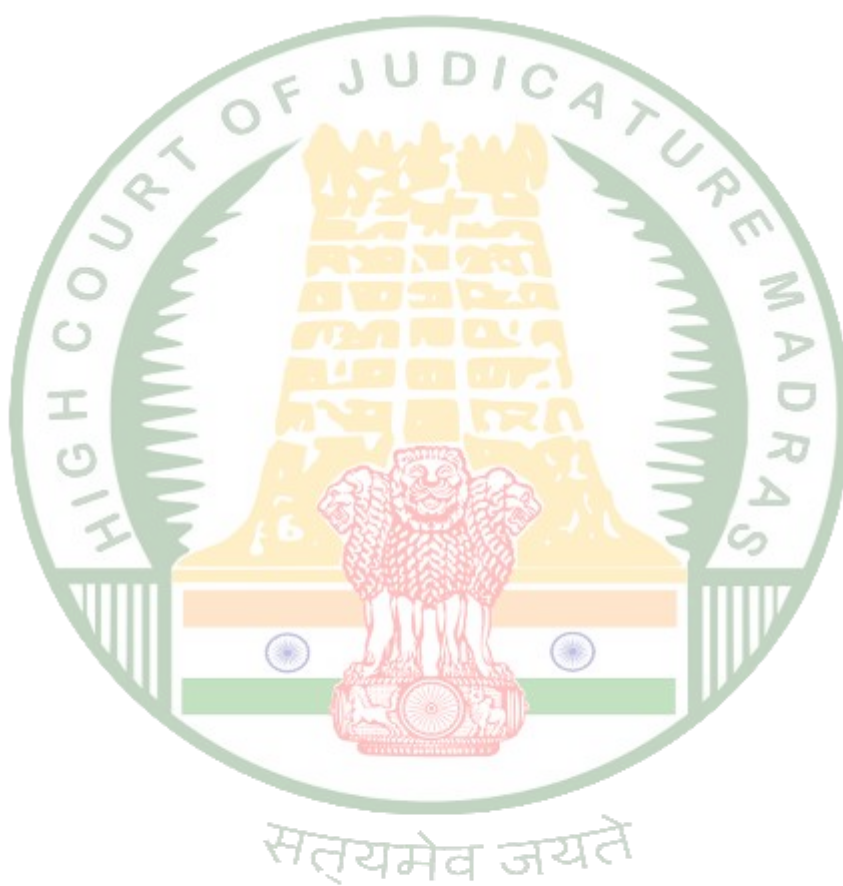
