COMMON ORDER

The petitioners have come to this Court seeking a mandamus to the respondent to pass orders on their representation dated 08.08.2017, collectively addressed by them seeking consideration of the benefit of pay scale, as per proceedings of the Registrar of Cooperative Societies made in Rc.No.92088/2008/SF3 dated 21.08.2008, on merits.

2. Mr.L.P.Shanmughasundaram, learned Special Government Pleader takes notice on behalf of the respondent.

3. This Court, while considering a similar prayer, has passed an order on 26.10.2017 in W.P.Nos.27475 and 27476 of 2017 [V.Saravanakumar and another v. Registrar of Cooperative Societies (Housing), Chennai] directing the respondent to consider the representation on merits. In view thereof, these writ petitions stand disposed of with a direction to the respondent to consider the pending representation of the petitioners on merits and pass appropriate orders in accordance with law, in the light of the proceedings of the Registrar of Cooperative Societies dated 21.8.2008, within a period of four weeks from the date of receipt of a copy of this order.
