This Court, at this stage, is not expressing any view on the claim made by the petitioner, as it is for the first respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the first respondent to consider the representations of the petitioner dated 16.10.2015 and 15.06.2017 and pass orders on the same on merits and in accordance with law, after hearing the rival claimants, if any. Such exercise shall be done by the first respondent within a period of four weeks from the date of receipt of a copy of this order. No costs.
