The petitioner seeks for a mandamus directing the respondents to consider her representation dated 10.07.2017, wherein and whereby she sought for granting transfer of patta in her name in respect of 1.58 cents of Punja land in S.No.273/3, S.No.273/4G, S.Nos.273/4H, 4K, 4M, 4L and S.No.273/5 in Vedal Village, Arakkonam Taluk, Vellore District, based on the settlement deed dated 15.03.2013.

4. The grievance of the petitioner before this Court, is that the said request has not been considered so far. This Court, at this stage, is not expressing any view on the claim made by the petitioner, as it is for the second respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the second respondent to consider the representation of the petitioner dated 10.07.2017 and pass orders on the same on merits and in accordance with law, after hearing the rival claimants, if any. Such exercise shall be done by the second respondent within a period of twelve weeks from the date of receipt of a copy of this order. No costs.
