O R D E R

Mr.E.Balamurugan, learned Additional Government Pleader takes notice for the respondents. By consent of the parties, the main writ petition is taken up for final disposal at the admission stage itself.

2. Heard both sides.

3. The petitioner seeks for a Mandamus to direct the respondents to consider the representations dated 07.02.2011 and reminders dated 01.09.2014 and 20.03.2015 for the issue of patta for the property bearing No.63/4,

Bajanai Koil Street, Elango Nagar, Padi, Chennai - 600 050.

4. The grievance of the petitioner is that the said request has not been considered so far. At this stage, this Court is not expressing any view on the merits of the claim made by the petitioner as it is for the 2nd respondent to consider and decide the same on merits and in accordance with law. However, considering the fact that the petitioner has already made a representation as early as in the year 2011 and the last of such representation was made on 20.03.2015, this Court is inclined to issue a direction to the 2nd respondent to consider the representation of the petitioner dated 20.03.2015 and pass orders on the same on merits and in accordance with law, after hearing the rival claimants, if any. Such exercise shall be done by the 2nd respondent within a period of twelve weeks from the date of receipt of a copy of this order. Accordingly, the writ petition is disposed of. No costs.
