Order : This petition coming on for orders upon perusing the petition and the Memorandum of Grounds in CRL A.234/2017 on the file of the High Court and upon hearing the arguments of M/S.G.KARTHIKEYAN, Advocate for the petitioner and of MR.V.M.R.RAJENTRAN Advocate on behalf of the Respondent the court made the following order:-

The petitioner was found guilty of committing the offence under Section 302 of the Indian Penal Code after a full fledged trial and he has been sentenced to undergo life imprisonment with a fine of Rs.5,000/-, for causing the death of a lady brutally by attacking her with a hammer on her right chest; dashing her head against the wall; smothering her using a pillow; and strangling her. Challenging the conviction and sentence, the petitioner has come forward with the appeal.

2. Pending appeal, the petitioner has filed the above petition, seeking suspension of sentence.

3. Heard both.

4. For the conduct held established after a full fledged trial by the prosecution and also considering the gravity of the offence, we see no justifiable reason to take any sympathetic view in the matter.

5. Accordingly, the above petition stands dismissed.
