the respondents 1 and 2 and Mr.A.Arumugam, counsel for the third respondent are present.

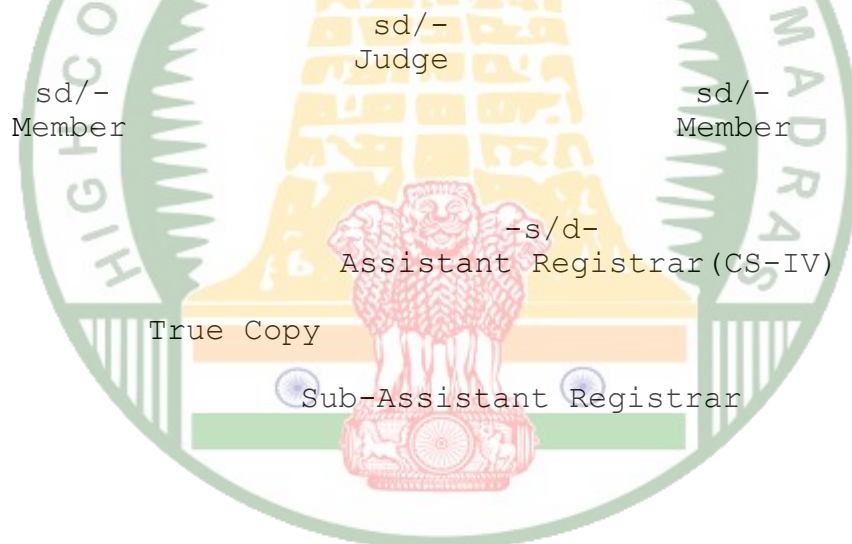
ORDER

4. In view of the same, the writ petition is disposed of as it has become infructuous and the award is passed accordingly. Consequently connected miscellaneous petition is closed.



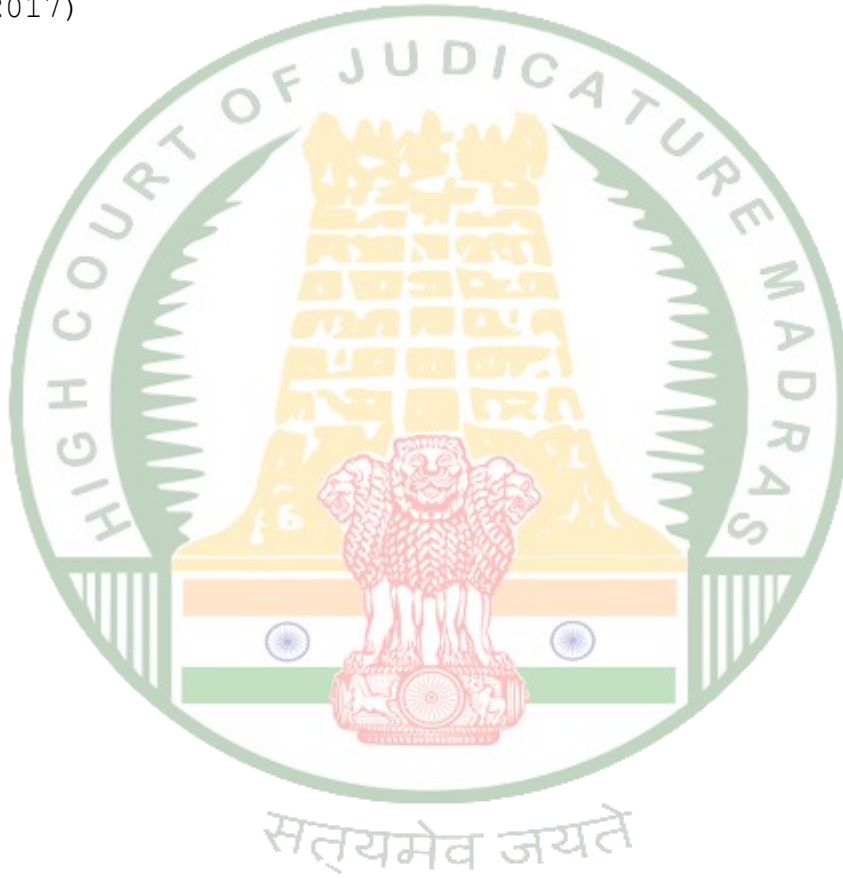
