3.In view of the endorsement so made, the intra court appeal is dismissed as withdrawn. No costs. Consequently, the connected miscellaneous petition is also closed.

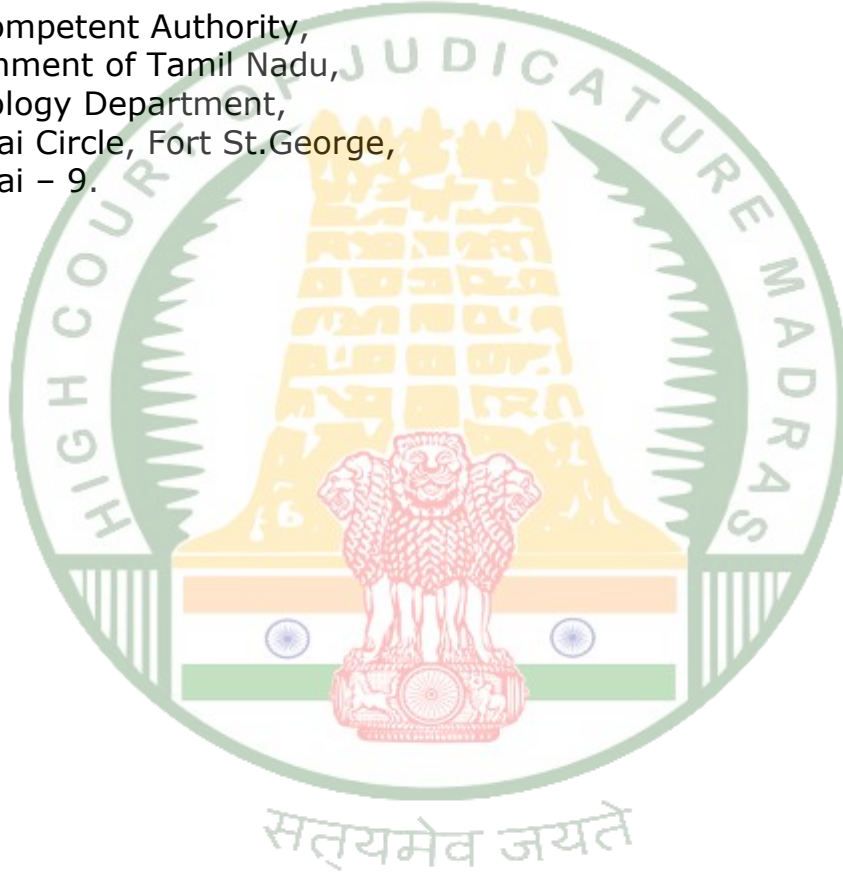
