Prayer in W.P.No.36228 of 2015: Petition filed under Article 226 of the Constitution of India praying to issue a writ of certiorarified mandamus to quash the demand notice issued by the third respondent in Na.Ka.No.6329/15 dated 09.10.2015 in respect of Item Nos.5 to 11 and consequently direct the third respondent to issue building planning permission in pursuance of proposed construction plan in respect of petitioner's property situated at No.5, Muthamil Street, East Tambaram, Chennai - 59.

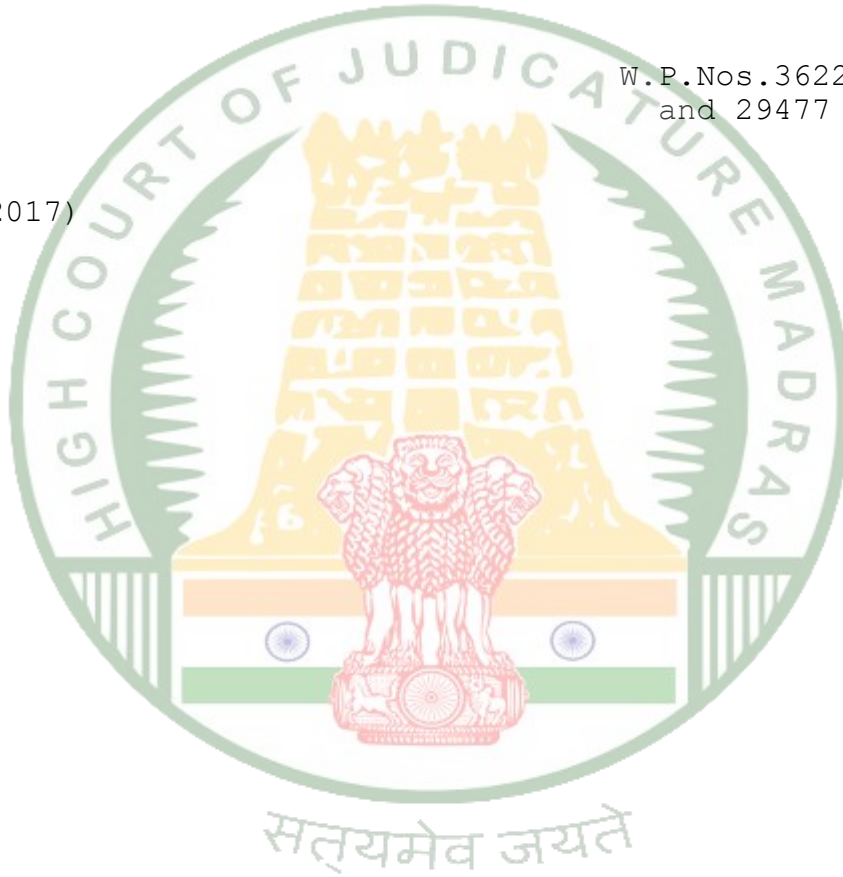
