2. The writ appeal has been filed challenging the order passed by the learned Single Judge directing the second appellant Board to declare the writ petitioner as being selected for the post of Post Graduate Assistant and forwarding her name.

It appears that in furtherance thereof, a Government Order in G.O.Ms.No.27 Higher Education (K2) Department dated 11.2.2014 has been issued in this regard which shows that the Government has approved that M.Sc Zoology (Specialization in Biotechnology) awarded by Lady Doak College affiliated to Madurai Kamaraj University is equivalent to M.Sc.Zoology.

4. In view of the above, we find that nothing remains to be considered in this writ appeal. Accordingly, the writ appeal is dismissed. No costs. The connected miscellaneous petitions are closed.
