The petitioner is further directed execute a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties to the like sum, to the satisfaction of the learned Judicial Magistrate (Fast Track Court) No.II, Erode, within a period of two weeks from the date of receipt of a copy of this order. The petitioner shall appear before the said court on the first working day of every month at 10.30 a.m., until further orders.
