Prayer in C.S.No.114 of 2016. Plaintiff is filed under Order IV Rule 1 of High Court O.S. Rules r/w. Order VII Rule 1 of CPC, praying for judgment and decree:

- a) for declaration that the Election Notification of the 2nd defendant dated 05.02.2016 in Circular No.5/2016 as ultra vires and invalid.
- b) for declaration that the list of valid nomination issued by the defendants 3 to 6 dated 12.02.2016 as ultra vires and invalid.
- c) for a mandatory injunction directing the defendants 3 to 6 to issue fresh Election Notification and conduct the Election for the year 2015-2018 strictly as per the bye laws of the Association.
- d) for costs of the suit.

Prayer in C.S.No.146 of 2016. Plaintiff is filed under Order IV Rule 1 of High Court O.S. Rules r/w. Order VII Rule 1 of CPC, praying for judgment and decree:

- a) for declaration that the final list of eligible candidates and the election result dated 19.02.2016 in Circular No.Election:2016:03 declaring all the candidates as unopposed as illegal, ultra vires and invalid.
- b) for costs of the suit.
