Today, when these matters were taken up for consideration, learned Additional Public Prosecutor submitted that in the cases in Crime Nos.120 to 123 of 2013, after completion of investigation, charge sheet was filed before the learned Judicial Magistrate No.I, Pollachi and the same was taken on file. Subsequently, after trial, the petitioners were also acquitted from the charges by order dated 10.09.2013.

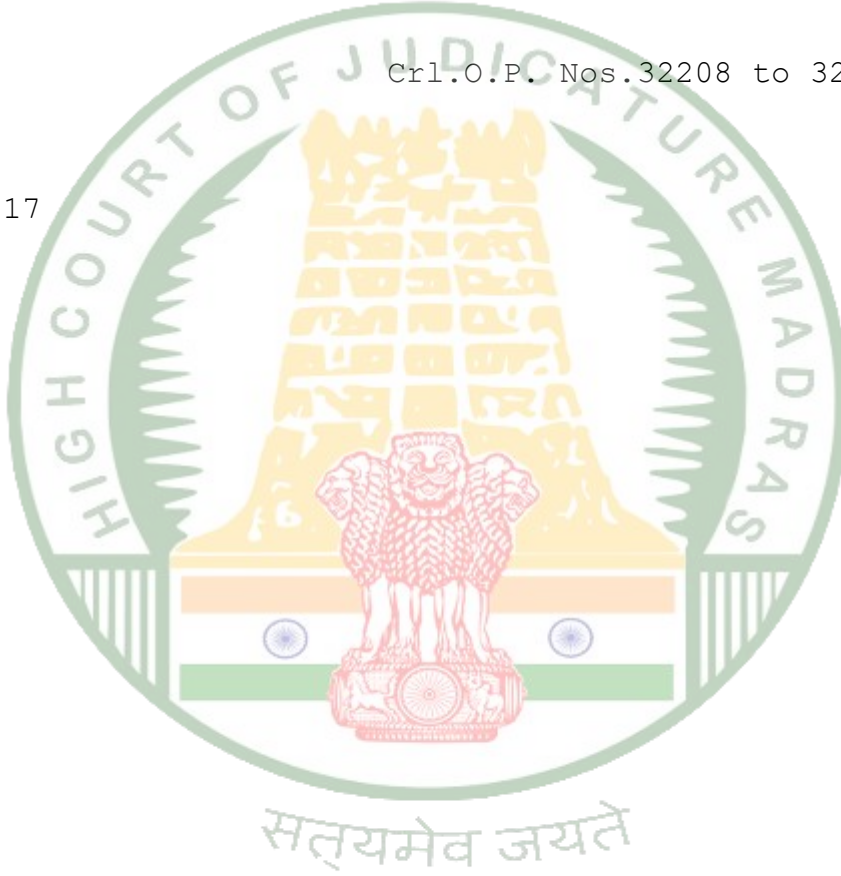
