Learned Standing Counsel for the respondents 4 & 5 submits that though initially an interim order was granted on 25.07.2003, as the same was vacated on 05.09.2003, tax was deducted on the entire commission, and returns were filed and as of now nothing requires to be adjudicated as the relevant assessment years are already over.
