Possession notice dated 28.12.2012, is challenged in this writ petition.

2. Record of proceedings shows that on 29.01.2013, writ petition has been dismissed for non prosecution. Thereafter,

satisfied with the reasons assigned in the supporting affidavit to M.P.No.1 of 2013 in W.P.No.1272 of 2013, a Hon'ble Division Bench vide order dated 18.02.2013, has restored the writ petition to file.
