During the pendency of this writ petition the Enquiry Proceedings were concluded and the respondents have not passed any final order, on account of the pendency of the present writ petition. In view of the fact that the Enquiry Proceedings were completed the respondents are at liberty to take a final decision in the Disciplinary Proceedings and pass orders on merits and in accordance with law.

3. Accordingly, the writ petition stands closed. However, there is no order as to costs. Consequently, the connected Miscellaneous Petitions are closed.
