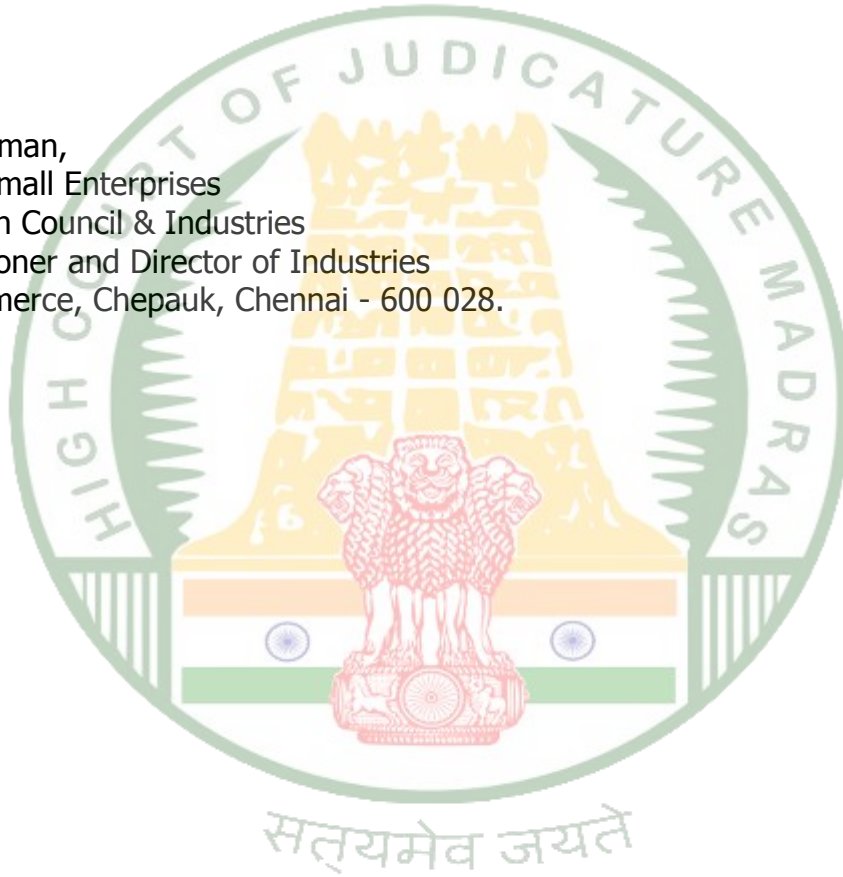
The civil revision petitions are allowed as indicated above. No costs.
