Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Certiorarified Mandamus, calling for the entire records from the file of the respondents 1 and 2 who have issued a notice under section 379 (A) of the Chennai City Municipal Corporation Act IV of 1919 dated 28.06.2004 and quash the same as illegal and repugnant in law at the same time directing the respondents 1 and 2 to remove the sealing of the flour mill premises at old Door No.56, New No.6, North Mada Street, Mylapore, Chennai 600 004.

W.P.No.24388 of 2004:

Writ Petition filed under Article 226 of the Constitution of India, praying for issuance of a Writ of Mandamus, directing the respondents 1 and 2 to accept the tenancy issued by the 3rd respondent in favour of the petitioner dated 11.4.2000 as no objection certificate for issuing a fresh licence in favour of the petitioner for running the flour mill at old no.56, New No.6, North Mada street, Mylapore, Chennai 600 004.

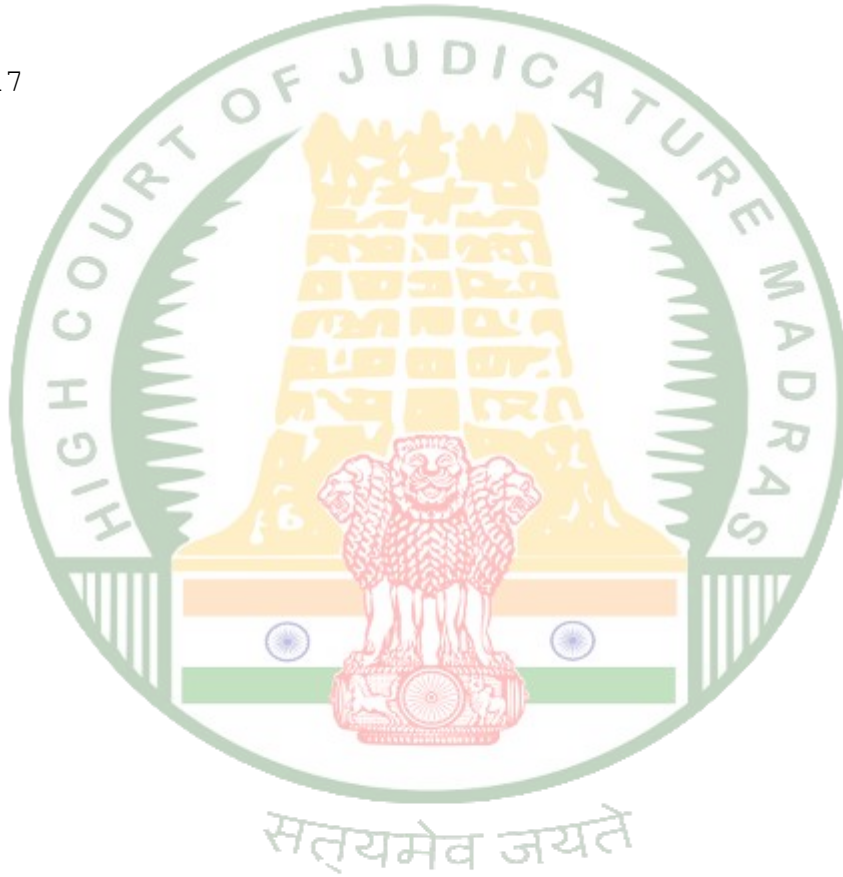
