[Order of the Court was made by M.VENUGOPAL, J.]

The Learned Counsel for the Petitioner has made an endorsement in the Writ Petition to the following effect:

"The Petitioner has challenged the Order passed by the Fee Fixation Committee dated 22.4.2013 which is valid only upto 2015-2016. Hence the Petitioner may be permitted to raise all these grounds raised herein before the present Fee Fixation Committee while fixing the fee for the subsequent years."

2. At this stage, it is pertinent to mention that this Court is not expressing any opinion on the correctness or otherwise of the Order dated 22.04.2013 passed by the 3rd Respondent during the Academic Years 2013-2014, 2014-2015 and 2015-2016. At the same time, this Court make it quite clear that while exercising the powers under Tamil Nadu Private Schools (Regulation of Collection of Fees) Act, 2009 for verifying the correctness of the amount of fees collected by the Petitioner and taking any action for collection of excess fees from the current Academic Year (2017-2018) onwards, the Private School Fee Determination Committee shall not be influenced by the findings in the aforesaid order dated 22.04.2013 and that orders in this regard passed by the Committee shall be on merits and in accordance of Law.
