Petition filed under Article 226 of the Constitution of India, praying to issue a Writ of Habeas Corpus, to call for the records in connection with the order of detention passed by the second respondent dated 09.08.2016 in Memo No.865/BCDFGISSSV/2016 against the petitioner's husband Karthik @ Escape Karthik, son of Sugumar, aged about 28 years, who is confined at Central Prison, Puzhal, Chennai and set aside the same and direct the respondents to produce the detenu before this Court and set him at liberty.

This Habeas Corpus Petition has been filed, by the wife of the detenu, namely, Karthik @ Escape Karthik, to issue a Writ of Habeas Corpus, to call for the records connected with the detention order of the second respondent, in Memo No.865 / BCDFGISSSV/2016, dated 09.08.2016 and set aside the same and

direct the respondents to produce the body and person of the petitioner's husband, by name Karthik @ Escape Karthik, son of Sugumar, aged about 28 years, detained in Central Prison, Puzhal, Chennai, before this Court and set him at liberty.

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the husband of the petitioner dated 09.08.2016 has been revoked by the Government in G.O.Rt.No.4659, dated 28.09.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, the Habeas Corpus Petition is dismissed as infructuous.
