This Habeas Corpus Petition has been filed, by the cousin brother of the detenu, namely, S. Shanmugasundaram, to issue a Writ of Habeas Corpus, to call for the records connected with the detention order of the second respondent, in Memo No.889/BCDFGISSSV/2016, dated 11.08.2016 and set aside the same

and direct the respondents to produce the body and person of the petitioner's cousin brother, by name S.Shanmugasundaram son of Sivakaminathan, aged about 30 years, detained in Central Prison, Puzhal for Men, Chennai, before this Court and set him at liberty.

2. The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the cousin brother of the petitioner dated 11.08.2016 has been revoked by the Government in G.O.Rt.No.4841, dated 06.10.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, the Habeas Corpus Petition is dismissed as infructuous.
