Challenge is made to the order of detention passed by the second respondent vide Proceedings in No.925/BCDFGISSSV/2016 dated 18.08.2016, whereby the detenu, namely Govinda Kailash Varma @ Kakkada Govindan, S/o Kailash Varma, aged about 31 years, was ordered to be detained under GOONDA as contemplated Section 2(f) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the petitioner dated 18.08.2016 has been revoked by the Government in G.O. Rt. No.4870, HOME, PROHIBITION & EXCISE (X) DEPARTMENT, dated 06.10.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is dismissed as infructuous.

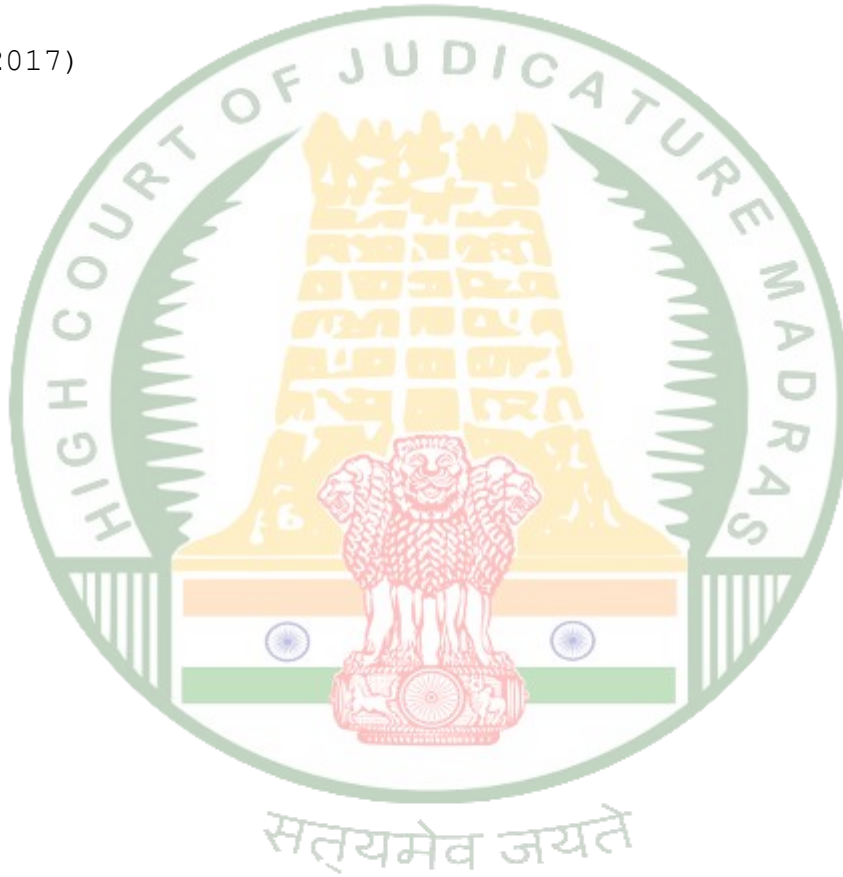
