Challenge is made to the order of detention passed by the first respondent vide Proceedings in C.No.43/G/IS/2016 dated 04.10.2016, whereby the detenu, namely R.Arunkumar, S/o Rajan, aged about 27 years, was ordered to be detained under GOONDA as contemplated Section 2(f) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the first respondent as against the petitioner dated 04.10.2016 has been revoked by the Government in G.O. Rt. No.5951, HOME, PROHIBITION & EXCISE (XII) DEPARTMENT, dated 25.11.2016 and he has also produced a copy of the said order.
