the first respondent vide Proceedings in Memo No. Cr.M.P.NO.33/G/2016/E1 dated 02.11.2016, whereby the detenu, namely Sakthikumar S/o.Selvaraj, male, aged 27 years, was ordered to be detained under GOONDA as contemplated under Section 2(f) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the first respondent as against the petitioner's son dated 02.11.2016 has been revoked by the Government in G.O. Rt. No.6422, HOME, PROHIBITION & EXCISE (XII) DEPARTMENT, dated 22.12.2016 and he has also produced a copy of the said order.
