Challenge is made to the order of detention passed by the second respondent vide Proceedings in BCDFGISSSV/1147/2016 dated 04.11.2016, whereby the detenu, namely Pandu @ Pandurangan, S/o Arumugam, aged about 32 years, was ordered to be detained under GOONDA as contemplated Section 2(f) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the second respondent as against the petitioner's brother dated 4.11.2016 has been revoked by the Government in G.O. Rt. No.6408, HOME, PROHIBITION & EXCISE (X) DEPARTMENT, dated 22.12.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is dismissed as infructuous.
