Challenge is made to the order of detention passed by the first respondent vide Proceedings in Cr.M.P.No.34/G/2016/E1 dated 02.11.2016, whereby the detenu, namely Mohanraj, S/o Vadivel, aged about 26 years, was ordered to be detained

under GOONDA as contemplated Section 2(f) of the Tamil Nadu Act 14 of 1982.

2.The learned Additional Public Prosecutor would submit that the order of detention passed by the first respondent as against the petitioner's son dated 2.11.2016 has been revoked by the Government in G.O. Rt. No.6420, HOME, PROHIBITION & EXCISE (XII) DEPARTMENT, dated 22.12.2016 and he has also produced a copy of the said order.

3. Recording the submission of the learned Additional Public Prosecutor, this petition is dismissed as infructuous.
