The writ petition is filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus to call for the records on the file of the 1st Respondent in connection with the order passed by him in G.O.Ms.No.25, Handloom Handicrafts Textiles & Khadi (G2) Department dated 23.02.2010 to the extent of fixing lesser pay than that of the pay already received by the Petitioner on daily wages basis and not having fixed the retirement age as 60 years and quash the same and direct the Respondents to pay atleast the same amount of payreceived by him on daily wages and fix atleast the age of 60 as the age of superannuation as done in the case of similarly situated employees of other departments viz. Anganwadi Workers Noon-Meal Organizers and the candidates fallen under the Tamil Nadu Basic Service.
