Challenge is made to the order of detention passed by the second respondent vide Proceedings in No.1125/BCDFGISSSV/2016, dated 3.11.2016, whereby the detainee, namely Prakash, son of Vijayan, aged about 32 years, was confined at Central Prison-II, Puzhal, Chennai.

Rt. No.6440, Home, Prohibition & Excise (XIII) Department dated 22.12.2016, and he has also produced a copy of the said order.
