This petition is filed to withdraw H.M.O.P.No.1607 of 2015 from the file of the learned Principal Judge, Family Court at Chennai and transfer the same to the file of the learned Sub Court, Arani, to be heard along with HMOP. No.67 of 2015.

2. Heard the learned counsel appearing for the petitioner and the learned counsel appearing for the respondent.

3. The learned counsel appearing for the respondent has no objection to transfer the H.M.O.P. No.1607 of 2015 pending on the file of the learned Principal Judge, Family Court, Chennai to the file of Sub Court, Arani and made an endorsement to that effect.

4. In view of submissions made by the learned counsel for the respondent and recording the endorsement so made by him, this petition is ordered. No.67 of 2015 filed by the petitioner, which is pending on the file of Sub Court, Arani. No costs. Consequently, connected miscellaneous petition is closed.
