the petitioner is not in a position to represent about the stage of the suit in O.S.No.35 of 2005 on the file of District Munsif Court, Palladam.

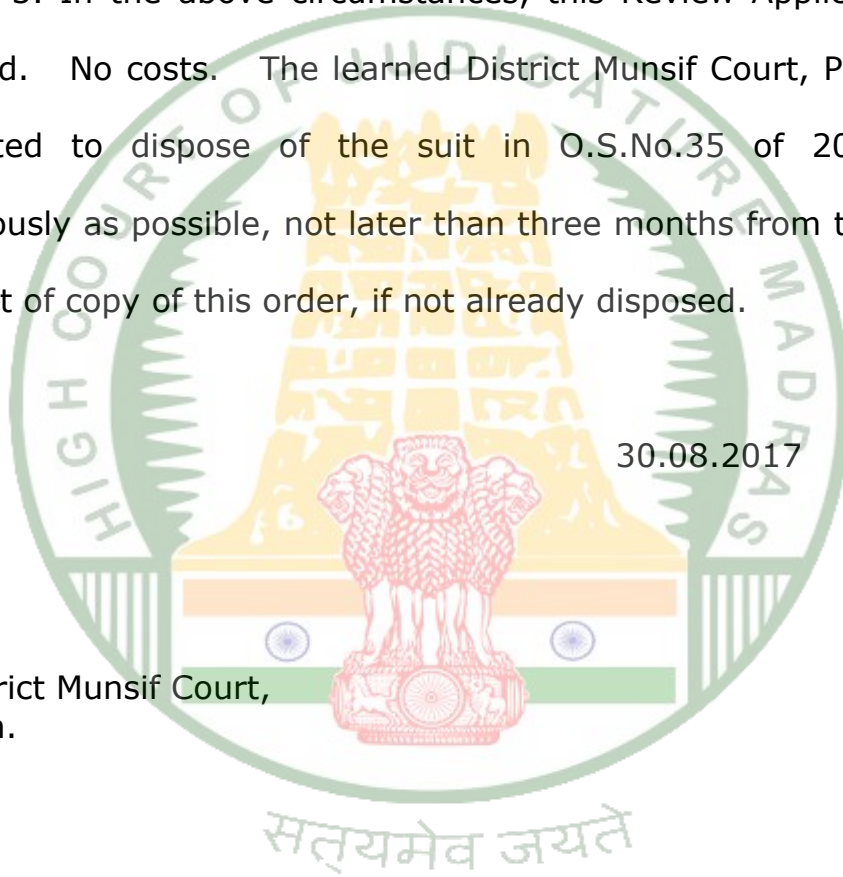
