In these Writ Petitions, the petitioners have challenged the orders passed by the first respondent, by which, licence L-2 granted in their favour, bearing Licence Nos.19/2000-01 and No.362 respectively were cancelled.

Admittedly, even the original licence held by the petitioners have expired.
