The school was ready to sympathetically consider the apology letter of the petitioner and by considering the pendency of the writ petition before this Court from 02.09.2016 and the absence of the petitioner from 03.08.2016 will be duly considered by the school authorities and appropriate orders will be passed.

3. Insofar as the pendency of the writ petition, the same is pending before this Court from 08.09.2016 as per the writ petition is pending by this Court from 08.09.2016 onwards taking into consideration, absence will be duly given to consider and pass appropriate orders.

4. Recording the submissions so made by the learned Special Government Pleader, this petition is disposed of. No costs. Consequently, connected miscellaneous petition is closed.
