ORDER

This Criminal Original Petition has been filed seeking a direction to direct the respondents police to secure the accused in the above Cr.No.409 of 2016 and similarly expedite the filing of the charge sheet in this connection at the earliest before the concerned Court.

2. Heard the learned counsel for the petitioner and the learned Additional Public Prosecutor appearing on behalf of the respondents.

3. Whenever any information in relation to commission of cognizable or non cognizable offence is received, the police officer shall adhere to the procedure contemplated under Sections 154 & 155 of the Criminal Procedure Code and after conducting necessary enquiry/investigation, file final report under Section 173 of Cr.P.C. Such investigation under Chapter XII of the Criminal Procedure Code shall be completed without

any unnecessary delay. The delay in filing a final report in the present case is inordinate and unjustified. Hence, it would be appropriate to direct the Investigating Officer to file a final report within a stipulated time.

4. Considering the facts and circumstance of the case, this Court directs the respondents police to complete the investigation in Crime No.409 of 2016 pending on his file and file a final report within a period of four weeks from the date of receipt of a copy of this order. This Criminal Original Petition is disposed of accordingly.
