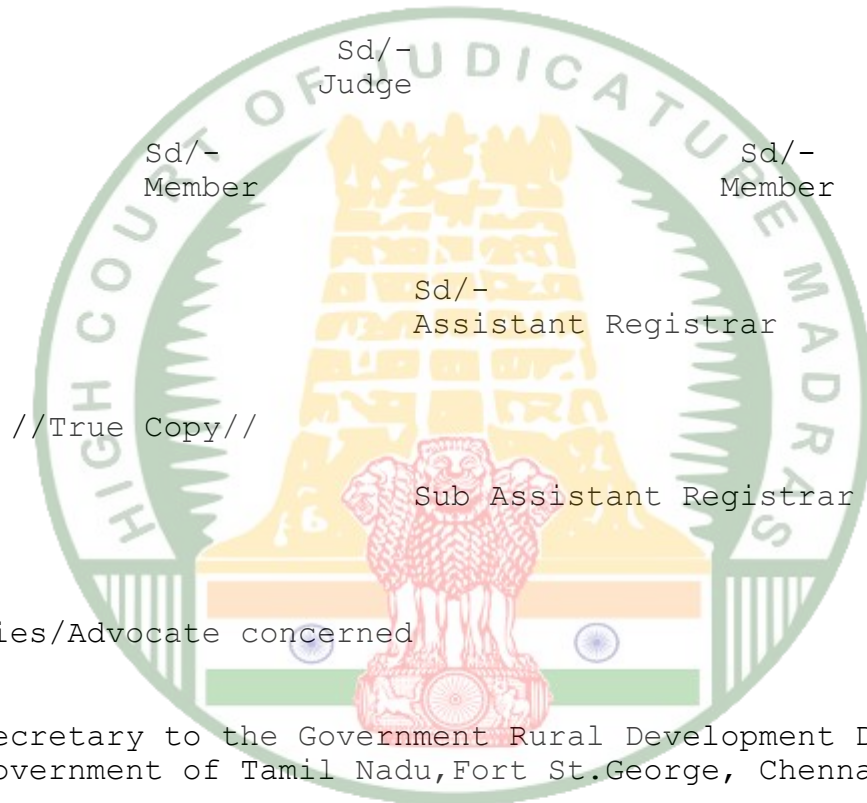
2. Accordingly, this matter is disposed of and the award is passed.
