COMMON ORDER

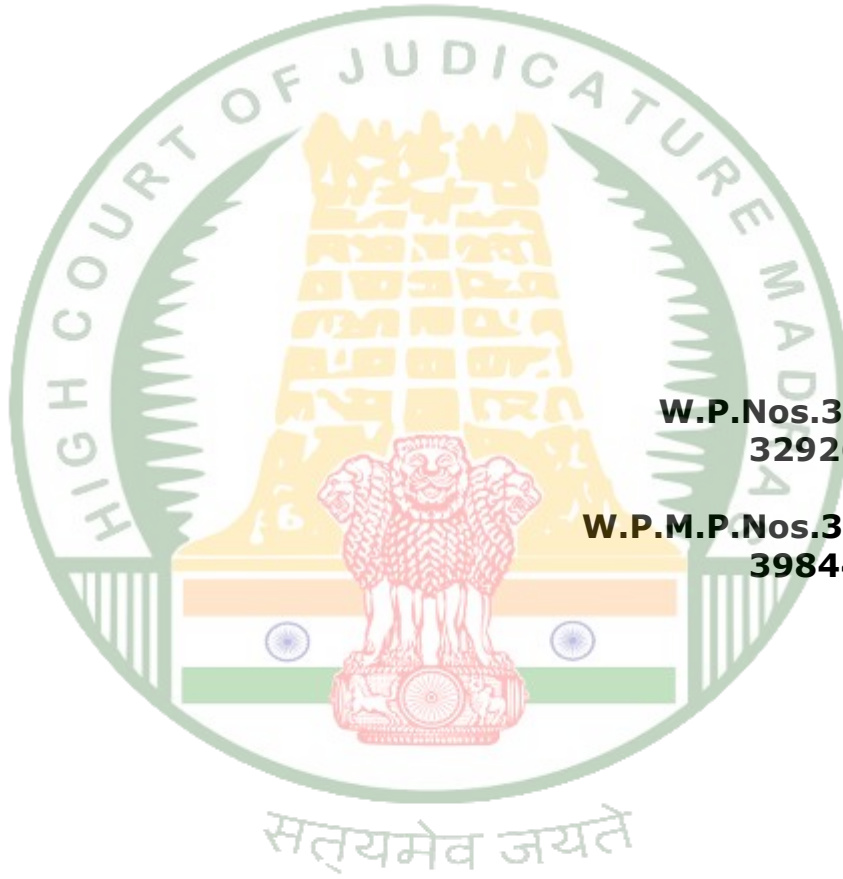
